GASCA members can currently engage in 35 thematic working groups and regional groups, which are dedicated to specific social and cultural anthropological topics.

All members receive regular GASCA-newsletters in pdf format. Membership includes the right to stand for election at the biennial GASCA conferences, the right to vote at the general meeting and in the working groups as well as reduced participation fees.

NOTE: In accordance with A §5 of the statutes, **full** members must identify themselves as ethnologists / social and cultural anthropologists. They need to be endorsed by two full, non-student members or honorary members. The chairperson approves new members, subject to them being later confirmed at the general meeting. Until their confirmation at the general meeting, new members have all rights and duties except the right to vote in the general meeting, which is granted after the membership is confirmed.

**Students** using a current study enrolment as ID can receive the same conditions as full members after their 4th semester. The passive right to vote is waived, but they can elect a student working group representative as delegate on the advisory board.

Supporting members can be people, corporations, associations and institutions under public and private law. They do not need an endorsement. The Executive Board decides their admission. For details see §§5-8 of the statutes.

DATA PROTECTION:

**Use of your personal data**

Your personal data will be processed for the following purposes as required to ensure the legitimate interests of the GASCA (Art. 6 para. 1 lit. f, GDPR):

- member administration and accounting (e.g. collection of membership fees or control of payments, forwarding of donation receipts);
- general activities of the association (invitations to general meetings and biennial conferences);
- distribution of the Zeitschrift für Ethnologie

In addition, there are various legal obligations (Art. 6 Para. 1 lit. c, GDPR) which may make the processing of your personal data necessary, e.g. tax regulations.

**Recipient of your personal data**

Within the association, access to your personal data is restricted exclusively to the branch office management and in some cases to the chairperson of the board and the working group/regional group coordinator (contact data only).

The office will send your name and postal address to Reimer-Verlag for the distribution of the Zeitschrift für Ethnologie.

For the purpose of checking GASCA memberships to enable members to receive discounts, we share data as required with the conference office of the institute with whom the GASCA board works to organise the biannual conference.

**Your rights**

Legally you have the following rights, which are to be checked in a case-by-case basis:

- The right to receive information about your personal data (Right to Information, Art. 15 GDPR),
- The right to request the rectification (Art. 16 GDPR) or deletion ('right to be forgotten', Art. 17 GDPR) of your personal data or the restriction of processing (Art. 18 GDPR),
- The right to receive your personal data in a structured, standard and machine-readable format (Right to data portability, Art. 20 GDPR),
- The right to revoke your consent at any time (Art. 7 GDPR), whereby the revocation does not affect the legality of the processing prior to revocation,
- The right to object to any processing of your personal data as described under "Use of your personal data" (Art. 21 GDPR),
- The right to lodge a complaint with a supervisory authority (Art. 77 GDPR).

**Confidentiality and data storage**

The branch management, the chairperson of the board and the working group/regional group coordinator, who have access to and/or process personal data, are obliged to treat this data confidentially in compliance with the applicable legal regulations. The data will be kept for the prescribed period of time as is required by the respective country.
